WHEREAS, the CVs received were referred to the PRDP Personnel Selection Committee per S.O. No. 564, Series of 2013, for evaluation on 24 February 2015;

WHEREAS, the PRDP Personnel Selection Committee agreed on the following criteria and

proceeded with the evaluation of the CVs for the position of Driver/Chauffer, to wit:

WHEREAS, on 24 March 2015, the SBAC received the PRDP Personnel Selection Committee Resolution Nos. 15-07, Series of 2015 for the hiring of the above-mentioned staff;

WHEREAS, the PRDP Personnel Selection Committee Resolution No. 15-06, Series of 2015 states that the salary of the hired applicant shall be 100% of the approved rate for six months and renewal of the contract shall be subject to evaluation and recommendation of the PRDP Personnel Selection Committee;

WHEREAS, the result of the overall evaluation for the position of Project Development Associate for I-PLAN Component, PRDP NPCO is hereby attached as Annex "A" and made an integral part hereof;

WHEREAS, based on the overall evaluation under the PRDP Selection Committee Resolution No. 15-06, Series of 2015, Ms. Judi Anne Felipe, whose overall average is 88.00%, was found to be the first ranking candidate, followed by Ms. Mary Char Bey N. De Castro, whose overall average is 86.50%, for the position of Project Development Associate for the I-PLAN Component, PRDP NPCO;

WHEREAS, the PRDP Selection Committee Resolution Nos. 15-06, Series of 2015 was referred to the Technical Working Group on 24 March 2015 whose evaluation was received by the SBAC on the same date. The TWG's evaluation is hereby attached as Annex "B" and made an integral part hereof;

WHEREAS, after review of the evaluation results, the SBAC adopted the recommendation of the Technical Working Group for the hiring of two (2) Project Development Associate for I-PLAN Component, PRDP-NPCO;

WHEREAS, it was further agreed that this resolution although agreed upon/approved in open session shall be signed by referendum by the Special Bids and Awards Committee Members;
