**SUBJECT: RECOMMENDING THE AWARD OF CONTRACT TO TRICOM DYNAMICS, INC. FOR THE SUPPLY AND DELIVERY OF THREE (3) UNITS OF LCD PROJECTOR FOR PRDP SOUTH LUZON CLUSTER, UNDER PRAS NO. 0119-N-2016 AND DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF DSLR CAMERA AND UNDERWATER CAMERA**

- Mode of Procurement: Shopping under the World Bank Procurement Guidelines

**WHEREAS**, Section VI.a., Paragraph II of the Philippine Rural Development Project Operations Manual -- Procurement Guidelines (based on the World Bank Procurement Guidelines) provides:

**Procurement of Goods**

"X X X

*Contracts estimated to cost US\$200,000 equivalent and above but not more than US\$1,000,000 will be procured through National Competitive Bidding (NCB). Procurement for off-the-shelf goods and small value contracts costing below \$200,000 will be awarded based on shopping procedures, by comparing price quotations obtained from at least three suppliers. Canvass forms and / or Request for Quotations shall be advertised in the PhilGEPS."*

**WHEREAS**, the DA-PRDP published through the PhilGEPS website for seven (7) days starting on August 10, 2016 a Request for Quotation/RFQ form for the supply and delivery of one (1) DSLR Camera and one (1) Underwater Camera and 3 units of LCD Projector with an EPC of PHP 230,000.00. The set deadline for the submission of RFQ form was on August 16, 2016;

**WHEREAS**, in response to the said advertisement and before the aforementioned deadline, five (5) suppliers submitted to the DA-PRDP SBAC their respective accomplished RFQ forms along with requisite documents. These documents were opened on August 16, 2016 to reveal the suppliers' respective quotations for the required goods, the details of which are laid out in the attached "Abstract of Bids" (*Annex "A" hereof*);

**WHEREAS**, the SBAC referred the suppliers' quotations and related documents to its Technical Working Group (TWG), which conducted a detailed evaluation thereof, ultimately submitting the results of said evaluation to the SBAC Secretariat on August 26, 2016 through a memorandum of even date (the memorandum is attached as *Annex "B" hereof*). The highlights of the TWG evaluation are as follows:

**For Category 1:**

1. **BayanPC Technologies Inc.** failed to submit required RFQ.
2. **Masangkay Computer Center** submitted complete documents but failed to put the name and signature of the representative on the flap of the envelope.
3. **Gamma Line Enterprises** failed to submit the required RFQ Form.
4. **Based on the documents submitted, the bidding for Category 1 (DSLR Camera and Underwater camera) is recommended failed.**

**For Category 2:**

1. **BayanPC Technologies Inc.** failed to submit required RFQ.

2. Masangkay Computer Center submitted complete documents but failed to put the name and signature of the representative on the flap of the envelope.
3. Pantronics International Corp. and Tricom Dynamics INC. complied with the requirements in the Request for Quotation (RFQ).
4. *Based on the documents submitted TRICOM DYNAMICS INC is the Lowest Complying and Responsive Bidder for Category 2 (LCD Projector) with 3 units.*

*WHEREAS*, after a careful review of the evaluation undertaken by the Technical Working Group (TWG), the Committee finds the said evaluation to the order and resolves to adopt its findings;

*WHEREAS*, it was further agreed that this resolution shall be approved by referendum by the Special Bids and Awards Committee;

*WHEREFORE, THE COMMITTEE RESOLVES AS IT IS HEREBY RESOLVED*, to recommend the approval of the Award of Contract to **TRICOM DYNAMICS, INC** for the **Supply and Delivery of LCD Projector** for PRDP South Luzon Cluster under PRAS No. 0119-N-2016 for having submitted the Lowest Calculated and Responsive Bid in the total amount of **One Hundred Twenty Thousand Pesos (Php 120,000.00)**, and

*To declare failure of bidding for the supply and delivery of DSLR Camera and Underwater Camera due to non-compliance of the suppliers who submitted the quotations.*
