RECOMMENDING THE AWARD OF CONTRACT FOR INDIVIDUAL CONSULTANCY FOR THE SERVICES OF ONE (1) ENTERPRISE DEVELOPMENT AND MARKETING SPECIALIST, FOR THE I-REAP COMPONENT OF THE PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) – NATIONAL PROJECT COORDINATION OFFICE (NPCO)

WHEREAS, under the World Bank procurement guidelines,¹ the mode "Selection of Individual Consultants" (SIC) may be availed of, to wit:

"V. SELECTION OF INDIVIDUAL CONSULTANTS

5.1 Individual consultants are normally employed on assignments for which (a) teams of personnel are not required, (b) no additional outside (home office) professional support is required, and (c) the experience and qualifications of the individual are the paramount requirement. When coordination, administration, or collective responsibility may become difficult because of the number of individuals, it would be advisable to employ a firm. xxx xxx

5.3. Individual consultants are selected on the basis of their relevant experience, qualifications, and capability to carry out the assignment. They do not need to submit proposals and shall be considered if they meet minimum relevant requirements which shall be determined by the Borrower on the basis of the nature and complexity of the assignment, assessed on the basis of academic background and relevant specific experience and, as appropriate, knowledge of the local conditions such as national language, culture, administrative systems, and government organization. The selection shall be carried out through the comparison of the relevant overall capacity of at least three qualified candidates among those who have, directly or through a firm, expressed interest in the assignment or have been directly approached by the Borrower. Individuals selected to be employed by the Borrower shall be the most experienced and best qualified, and shall be fully capable of carrying out the assignment. xxx."

WHEREAS, the Department of Agriculture-Philippine Rural Development Project (DA-PRDP) through its Special Bids and Award Committee (SBAC), caused the advertisement through the Philippine Electronic Procurement System (PhilGEPS) and PRDP website for seven (10) days, starting on January 11, 2020, a Request for Expression of Interest (REOI) and Terms of Reference relative to

the hiring of one (1) Enterprise Development and Marketing Specialist. The set deadline for the submission of Expressions of Interest with Curicula Vitae (CVs) was on 20 January, 2020;

WHEREAS, in response to the said REOI and before the aforementioned deadline, a total of eight (8) individuals who submitted their applications and CVs to the DA-PRDP SBAC through sealed envelopes (opened on 24 January 2020). The names of the applicants are as follows:

WHEREAS, the Special Bids and Awards Committee Secretariat (SBACs) endorsed the applicants to Personnel Selection Committee for evaluation, exam and interview. Copy of endorsement is hereto attached marked as Annex "B" and made an integral part hereof;

WHEREAS, the PSC has set the criteria for evaluation and selection among qualified applicants for positions or assignments in the PRDP as follows:

WHEREAS, upon the endorsement of the SBACs, the PSC facilitated the necessary screening and selection processes, which culminated in the evaluation of the qualifications of the applicants in accordance with the above criteria;

WHEREAS, on 03 March, 2020, the committee issued PSC Resolution No. 20-01, Series of 2020 [Annex "C" hereof], recommending the hiring of the Ms. Angela M. Alabo who have accordingly been selected for having obtained the highest rate (%) in the applicants' evaluation for the subject position/assignment:

WHEREAS, during the 9th SBAC Meeting on 09 March 2020, the SBAC disapproved the award of contract recommended by the PSC and for those hiring process which exceeded the ideal procurement timeline of 30 working days as indicated on Module 3 of PRDP Procurement Guidelines.

WHEREAS, on 14 April 2020 the PSC forwarded an appeal through a Resolution 20-03 for the reconsideration not to declare failure of bidding for those hiring exceeded 30 working days procurement timeline.
