SUBJECT: RECOMMENDING AWARD TO MASANGKAY COMPUTER CENTER FOR THE SUPPLY AND DELIVERY OF CELLCARDS TO BE USED OF PRDP PSO SOUTH LUZON CLUSTER

REFERENCES:

- Procurement Request (PR) No. 2021-009 with an Estimated Project Cost (EPC) of PhP378,000.00
- Included in the C.Y. 2021 PRDP Annual Procurement Plan (APP)
- Mode of Procurement: Shopping under World Bank Procurement Guidelines

WHEREAS, pursuant to Section VI of the Philippine Rural Development Project Operations Manual, Procurement Guidelines (based on the World Bank Procurement Guidelines), procurement for off-the-shelf goods and small value contracts costing below \$200,000 will be awarded based on shopping procedures, by comparing price quotations obtained from at least three suppliers;

WHEREAS, on 05 March 2021, the Request for Quotation (RFQ) for the Supply and Delivery of cellcards to be used of PRDP PSO South Luzon Cluster an EPC of PhP378,000.00 published through the PhilGEPs website on 16 March 2021, Deadline of submission of quotation/bid was set on 19 March 2021 at 12:00 NN;

WHEREAS, three (3) suppliers responded to the RFQ and submitted to the DA-PRDP SBAC their respective accomplished RFQ forms along with the requisite documents within the set deadline. The details of which are laid out in the attached "Abstract of bids" marked as Annex "A" and is made an integral part hereof;

WHEREAS, the SBAC referred the suppliers' quotations and related documents to its Technical Working Group (TWG) for the conduct of evaluation. The TWG evaluation report was submitted to the SBAC Secretariat on **22 March 2021**

The highlights of the TWG evaluation are as follows:

1. Three (3) bids were received within the deadline from suppliers namely: Klick Lucky Marketing, Masangkay Computer Center, Storm Hale Office & Equipment Trading;
2. Klick Lucky Marketing declared to be non-compliant due to non-submission of Mandatory Requirements such as: PhilGeps Documents and Affidavit of Undertaking and;
3. Storm Hale Office & Equipment Trading to be non-compliant due to non-submission of Affidavit of Undertaking;
4. **Masangkay Computer Center** complied with all the requirements stipulated in the Request For Quotation (RFQ);
5. The evaluation shows that **Masangkay Computer Center** is the Lowest Calculated Responsive Bidder (LCRB).

WHEREAS, copy of TWG Evaluation Report is hereto attached marked as Annex "B", and is made an integral part hereof;

WHEREAS, based on the TWG evaluation and careful review of the documents, the Committee found the same to be in order and resolved to adopt its findings;


WHEREAS, it was agreed that this resolution shall be approved through a referendum by the Special Bids and Awards Committee.


