- b) BIR registration;

a) The bidder/supplier must be an authorized dealer, distributor or manufacturer of the goods to be procured and the brand of the product offered must be in the Philippine market for at least 10 years prior to the bid opening; and

b) The bidder must have after-sales service facilities in major cities in the Philippines.

5. Quotations must be submitted on or before **April 18, 2024 at 10:00AM.**

6. The procurement procedures will be conducted in accordance with the provisions of the World Bank Procurement Guidelines and taking into consideration the related provisions in the Project Loan Agreement and Guidelines in the Procurement under the IBRD loans and IDA credits.
