SUBJECT: RECOMMENDING AWARD OF CONTRACT TO DURABUILT MOTORS, INC. FOR THE SUPPLY AND DELIVERY OF THIRTY (30) UNITS OF BRAND NEW, 4 X 4 PICK-UP WITH FIBER GLASS CANOPY AND NINE (9) UNITS OF BRAND NEW, 12-SEATER OR MORE PASSENGER VAN UNDER 2023-167

WHEREAS, pursuant to Section IV-1.2 of the Philippine Rural Development Project Operations Manual, Procurement Guidelines (based on the World Bank Procurement Guidelines), procurement for Goods and Non-Consulting Services costing above \$200,000 will be awarded based on NCB procedures;

WHEREAS, The Procurement Unit received an approved Procurement Request Action Slip (PRAS) on 30 August 2023 with supporting documents such as Procurement Plan, DBM Authority and Approved Technical Specifications copy of the said approved PRAS is hereby attached and marked as **Annex "A"** and made an integral part hereof;

WHEREAS, on November 18, 2023, the Philippine Bidding Documents was approved and republished at PhilGEPS Website. Copy of the bidding documents and proof of posting are hereby attached and marked as **Annex "B-1" & "B-2"** and made an integral part hereof;

WHEREAS, Notice of Meeting for the Pre-Bid Conference was forwarded on November 28, 2023 to three (3) observers namely: Philippine Chamber of Commerce and Industry (PCCI), Chamber of Automotive Manufacturers of the Philippine, Inc. (CAMPI) and Department of Agriculture – Commission on Audit for Foreign Assisted Projects (DA-COA_FAPs). Copy of the Notice of Meeting are hereby attached and marked as **Annex "C-1, C-2 & C-3"** and made an integral part hereof;

WHEREAS, On December 4, 2023 at 10:30AM the Pre-Bid Conference for the Supply and Delivery of Thirty (30) Units of Brand New, 4 x 4 Pick-Up with Fiber Glass Canopy and Nine (9) Units of Brand New, 12-Seater or More Passenger Van was conducted. Copy of the Minutes of the Meeting of Pre-Bid Conference is hereby attached and marked as **Annex "D"** and made an integral part hereof;

WHEREAS, based on the agreement, discussion and queries of suppliers raised during and after the Pre-Bid Conference, The Special Bids and Awards Committee issued Supplemental Bid Bulletin No. 1 for clarifying all the pending issues and concerns and changes to the requirement of the bidding documents, the Bid Bulletin were published on PhilGEPS Website on December 11, 2023 respectively. Copy of the said Bid Bulletin Nos. 1 is hereby attached and marked as **Annex "E"** and made an integral part hereof;

WHEREAS, Invitation to three (3) observers for the Bid Opening for the Supply and Delivery of Thirty (30) Units of Brand New, 4 x 4 Pick-Up with Fiber Glass Canopy and Nine (9) Units of Brand New, 12-Seater or More Passenger Van was issued on December 13, 2023. Copy of the said Invitations are hereby attached and marked as **Annex "F-1, F-2 & F-3"** and made an integral part hereof;

WHEREAS, on December 18, 2023 at 9:00AM the Bid Opening for the Supply and Delivery of Thirty (30) Units of Brand New, 4 x 4 Pick-Up with Fiber Glass Canopy and Nine (9) Units of Brand New, 12-Seater or More Passenger Van was conducted at PRDP 4th Floor Conference Room. three (3) bidders submitted their bid proposal namely: Durabuilt Motors, Inc., Innovation Motors Inc. and Axletech Inc. The Bid proposal submitted by Axletech Inc, is non-compliant due to attached PhilGEPS Red Membership which is non-compliant as per supplemental bid bulletin No. 1. Durabuilt Motors, Inc. and Innovation Motors Inc.

passed in the checking of eligibility documents and subjected to preliminary evaluation, detailed evaluation and post-qualification by the TWG & SBAC. Copy of the Minutes of the Meeting for the Bid Opening and approved eligibility checklist is hereby attached and marked as **Annex "G-1 & G-2"** and made an integral part hereof;

WHEREAS, based on the Technical Working Group preliminary and detailed evaluation dated December 18, 2023, the TWG determined the **DURABUILT MOTORS, INC.** being the Lowest Calculated bidder for the Supply and Delivery of Thirty (30) Units of Brand New, 4 x 4 Pick-Up with Fiber Glass Canopy and Nine (9) Units of Brand New, 12-Seater or More Passenger Van. Copy of the said detailed evaluation is hereto attached and marked as **Annex "H"** and made an integral part hereof;

WHEREAS, notice of Post-Qualification to the **DURABUILT MOTORS, INC.** was issue on December 19, 2023, verification on the availability of Thirty (30) Units of Brand New, 4 x 4 Pick-Up with Fiber Glass Canopy and Nine (9) Units of Brand New, 12-Seater or More Passenger Van. Copy of the said notice is hereto attached and marked as **Annex "I"** and made an integral part hereof;

WHEREAS, on December 19, 2023 **DURABUILT MOTORS, INC.** submitted a certification from Toyota Subic, Inc. stating that they have sufficient stock of Thirty (30) Units of Brand New, 4 x 4 Pick-Up with Fiber Glass Canopy and Nine (9) Units of Brand New, 12-Seater or More Passenger Van Copy of the said certification is hereto attached and marked as **Annex "J"** and made an integral part hereof;

WHEREAS, based on the Technical Working Group detailed evaluation, verification and post qualification and submitted Bid Evaluation Report (BER) on dated December 19, 2023, the TWG recommends to the SBAC to award the contract to **DURABUILT MOTORS, INC.** being Single Calculated and Responsive Bidder for the Supply and Delivery of Thirty (30) Units of Brand New, 4 x 4 Pick-Up with Fiber Glass Canopy and Nine (9) Units of Brand New, 12-Seater or More Passenger Van. Copy of the said BER is hereto attached and marked as **Annex "K"** and made an integral part hereof;

WHEREAS, based on the TWG evaluation and careful review of the documents, the Committee found the same to be in order and resolved to adopt its findings;


NOW THEREFORE, THE COMMITTEE RESOLVES AS IT IS HEREBY RESOLVED, to recommend award of contract to **DURABUILT MOTORS, INC** as the Single Calculated and Responsive Bidder in the amount of **SIXTY-FOUR MILLION ONE HUNDRED NINETY NINE THOUSAND NINE HUNDRED SIXTY ONE PESOS (PhP64, 199,961.00)** for the **SUPPLY AND DELIVERY OF THIRTY (30) UNITS OF BRAND NEW, 4 X 4 PICK-UP WITH FIBER GLASS CANOPY AND NINE (9) UNITS OF BRAND NEW, 12-SEATER OR MORE PASSENGER VAN** under **PRAS No. 2023-167**.






