1. The Government of the Philippines (GoP) has received a Loan from the World Bank towards the cost of Philippine Rural Development Project and it intends to apply part of the proceeds of this Loan to payments under the contract for the Construction of Surong Bridge and Upgrading of Barangay Aguas Farm to Market Road /PRDP-SU-IB-R04B-OCM-002-000-000-2023-FMB.
2. The **Provincial Government of Occidental Mindoro**, implementing partner of the Department of Agriculture, now invites bids for **Construction of Surong Bridge and Upgrading of Barangay Aguas Farm to Market Road**. Completion of the Works is required by **457 calendar days**. Bidders should have completed, within the last ten (10) years, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted in accordance with relevant procedures for open competitive bidding as specified in the IRR of RA 9184 (R.A. 9184), with some amendments, as stated in these bidding documents and is open to all bidders from eligible source countries as defined in the applicable procurement guidelines of the World Bank. The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification. The Estimated Project Cost for this project is **Two Hundred Sixty-Three Million Two Hundred Forty-Four Thousand Pesos (PhP263,244,000.00)**.
4. BPI Compound, Visayas Ave. Diliman, Quezon City, and upon payment or depositing to the **Provincial Government of Occidental Mindoro Account No. 0882-1118-06** of a non-refundable fee for the bidding documents in the amount of **Ten Thousand Pesos (PhP10,000.00)** not later than the submission of their bids.

The LGU Treasurer's official receipt, the bank teller's validated deposit slip or **printed receipt from online payment** serves as the proof of payment.

Digital payment shall mean payment using the likes of PayMaya, IAccess, Smart Money, GCash, Coins.ph and other means of digital payment.

The DA, however, requires that all potential contractors who will be awarded contract under the project shall have undergone geotagging training provided by the PRDP Project Support Office.

7. Bids must be duly received by the BAC Secretariat on or before **July 31, 2024** at **9:00 A.M.** at the **2nd Floor PAGCOR Socio Civic Center Capitol Compound, Barangay Payompon, Mamburao, Occidental Mindoro**. All bids must be accompanied by a **Bid Securing Declaration**.

Bids will be opened on **July 31, 2024** at **9:00 A.M.** at the **2nd Floor PAGCOR Socio Civic Center Capitol Compound, Barangay Payompon, Mamburao, Occidental Mindoro** with invitation link (**<https://us06web.zoom.us/j/87423561249?pwd=F1Y1N3R5Kdd0dbwTu8EDIKzKB14RjF.1>**), which shall be open to all interested parties. Bids will be opened in the presence of bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The Provincial Government of Occidental Mindoro reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders and without disclosing any reason and accept the offer most advantageous to the Provincial Government of Occidental Mindoro.
